BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer \$85,000 within Gas Tax Reserve Fund (CIP 90-220) to Monroe Avenue - Terrace Drive Drain Fund (CIP 11-154) of The City of San Diego, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the construction and related costs of Monroe Avenue - Terrace Drive Drain.
