WHEREAS, the opening of new restaurants and other entertainment facilities within Centre City is of great importance to the attractiveness and economic vitality of downtown; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Council hereby finds that the granting of alcoholic beverage licenses to redeveloped and newly developed restaurants and other entertainment facilities within Centre City pursuant to the City's redevelopment efforts is necessary and desirable.

BE IT FURTHER RESOLVED, that the Alcoholic Beverage Control Department of the State of California is hereby requested to favorably consider the granting of licenses to appropriate facilities which are constructed or redeveloped in accordance and consistent with the City's redevelopment plans.
