That the low bid of LES LAND ENTERPRISES, INC. dba TRIPLE L ENTERPRISES is hereby accepted and the City Manager is hereby authorized to execute a contract for MAINTENANCE AND OPERATIONS ASSISTANCE OF THE CONVENTION AND PERFORMING ARTS CENTER as may be required for a period of one (1) year beginning May 1, 1978 through April 30, 1979 for the total surcharge of eighteen percent (18%) of wage rates on file in the Purchasing Department, with an option to renew the contract for four (4) additional one (1) year periods.
