BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a lease agreement with DALEY ENTERPRISES, with regard to City-owned property located in the Otay Lakes Reservoir Basin area for the purpose of cattle grazing, at an annual rental of \$1,200 for a term of three years, under the terms and conditions set forth in the form of lease agreement on file in the office of the City Clerk as Document No. 763348.

BE IT FURTHER RESOLVED, that the provisions of Paragraph 12 on Page 3 of Council Policy 700-10 relating to visibility and public knowledge of proposed agreements are hereby waived.
