

RESOLUTION NO. 220728Adopted on APR 25 1978

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Mary C. Bachman	Library	\$1,000	Ms. Bachman is an Intermediate Typist. She suggested that the Library IBM transaction cards be color coded to eliminate the search required when accessing cards for overdue books. The implementation of this idea has saved 2,210 hours of search time in the Central Library alone. Savings are estimated at \$10,374.
Michael A. Rubalcava Harry F. Haas	Police	\$ 490	Mr. Rubalcava is a Field Representative and Mr. Haas is a Police Officer. They suggested that the Abandoned Vehicle Detail discontinue appraising vehicles impounded due to changes in the Civil Code. The implementation of this idea saves 832 hours annually. Savings are estimated at \$4,884.
David G. Kemp	Engineering & Development	\$ 340	Mr. Kemp is an Assistant Civil Engineer. He suggested that an Input Editing Feature be incorporated into each data deck of cards used by the Floodplain and Beach Erosion Section. The implementation of this idea saves 164 hours annually as well as computer time. Estimated savings are \$3,410.
James E. Sewell Arthur F. Robertson	Fire	\$ 105	Mr. Sewell is an Engineer, and Mr. Robertson is a Captain. They suggested that the printing portion of the Fire Department's photography service be eliminated until copies of photographs are required. Since photographs are not required on many pictures taken, savings are estimated at \$1,050.
