WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Albert P. Gaudio	Police	\$ 90	Mr. Gaudio is an Equipment Mechanic. He suggested that brake pad wear-out indicators be installed on Police vehicles. Savings to date have been \$928. This is a partial award pending a final 12-month review.
Tom Hernandez	General Services	\$ 75	One year ago Mr. Hernandez suggested that a new type of irrigation head be used to prevent vandalism and aid in the ease of repair of damaged heads. One year of experience has shown an additional savings of \$746.
JoAnne Gilbert	Housing and Community Services	\$ 70	Ms. Gilbert was an Intermediate Typist at the time of her suggestion. She suggested that the CETA "Job Finder" utilize an abbreviated form of description for each job advertised. This saves approximately \$710 annually in typing time and printing costs.
Allan H. Getter	Transportation	\$ 50	Mr. Getter is a Van Driver in the Special Transportation Division. He suggested that fare boxes be removed from Dial-A-Ride vehicles. This is both a cost and safety improvement. Estimated annual savings are \$4,800. This is a partial award pending a final 12-month review.
James von Rummelhoff	Police	\$ 45	Mr. von Rummelhoff is an Evidence Technician. He suggested that registrants be photographed with Polaroid film rather than conventional methods. This saves \$430 annually in photographing time and costs.
