William C. Buscher	Park and Recreation	\$ 20	Mr. Buscher is a Utility Worker I in the Park Division. He suggested several safety modifications to the sidewalk vacuums. This is a safety award.
Maureen Whelan	Financial Management	\$ 20	Ms. Whelan is a Junior Typist. She suggested that vanities and mirrors in CAB ladies' rest rooms be relocated. A warning sign has been placed on the inside doors of the rest rooms. This is a safety award.
Ronald L. Sisco	Fire	\$ 20	Mr. Sisco is a Fire Fighter. He suggested that non-skid strips be placed on COB stairways. This is a safety award.
Sally A. Vecchitto Jeanne F. Goncalves	Risk Management	\$ 10	Both Ms. Vecchitto and Ms. Goncalves are Intermediate Typists. They suggested a better filing system for the Safety Glass program. Estimated savings are \$115 annually.
