
BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$2,500 from Capital Outlay Fund 245, C.I.P. 11-150 (Waring Road Drain) for such acquisition and related expenses, is hereby authorized and approved.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
