That Change Order No. 1, dated March 15, 1978, heretofore filed with the City Clerk of said City as Document No. 763383 issued in connection with the contract between The City of San Diego and Arrow Electric for CONSTRUCTION OF STREET LIGHTING SYSTEMS ON UNIVERSITY AVENUE BETWEEN WINONA AVENUE AND 54TH STREET, said contract having been filed in the office of the City Clerk as Document No. 762108, be and the same is hereby approved; and the change therein set forth, amounting to an increase in the contract price of \$3,996, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$2,719 be hereby authorized out of Capital Outlay Fund Reserve 245 of The City of San Diego, solely and exclusively, for the purpose of providing funds for the above mentioned project and related costs, thereby amending the contract amount to \$15,807.
