BE IT FURTHER RESOLVED, that the expenditure of Four Thousand Dollars (\$4,000) from Park Service District Fund 11371; Five Thousand Dollars (\$5,000) from Park Service District Fund 11473; Five Thousand Dollars (\$5,000) from Park Service District Fund 11224; One Thousand Dollars (\$1,000) from the Environmental Growth Fund 2505; Four Thousand Dollars (\$4,000) from Gas Tax Fund 219 and Eight Thousand Dollars (\$8,000) from the Capital Outlay Fund is hereby authorized solely and exclusively for the purpose of providing funds for the above services.
