BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$4,158,232.00 by Hensel Phelps Construction Co., a Colorado corporation, for the CONSTRUCTION OF THE NORTH HARBOR DRIVE BRIDGE AT THE NAVY ESTUARY in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 761930.
2. That the expenditure of \$3,820,830.00 is hereby authorized out of the Gas Tax Fund 220; that the expenditure of \$40,000.00 is hereby authorized out of the Capital Outlay Fund 245 CIP No. 53-025; and that the expenditure of \$550,528.00 is hereby authorized out of the Capital Outlay Fund 245, Unallocated Reserve (Flood Control Right-of-way); and that the expenditure of \$150,000.00 is hereby authorized out of the Gas Tax Fund 220 Reserve of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
