VACATION OF THE SOUTHERLY HALF OF WALNUT STREET,
FROM OTSEGO DRIVE TO FALCON STREET, AND THE
WESTERLY HALF OF GOLDFINCH STREET, FROM WALNUT
STREET TO BROOKES AVENUE

WHEREAS, it is proposed that the southerly half of
WALNUT STREET, from Otsego Drive to Falcon Street, and the
westerly half of GOLDFINCH STREET, from Walnut Street to
Brookes Avenue be vacated; and

WHEREAS, there is no present or prospective use for the
streets either for the public street system for which the
rights-of-way were originally acquired or for any other
public use of a like nature that can be anticipated; and

WHEREAS, the public will benefit from the vacation
through improved utilization of land; and

WHEREAS, the vacation or abandonment is not incon-
sistent with the General Plan or an approved Community Plan;
and

WHEREAS, the public street system for which the rights-
of-way were originally acquired will not be detrimentally
affected by this vacation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San
Diego, California, that the southerly half of WALNUT STREET,
from Otsego Drive to Falcon Street, and the westerly half of
GOLDFINCH STREET, from Walnut Street to Brookes Avenue, as
more particularly referred to in Resolution of Intention
No. 220537, is unnecessary for present or prospective
public street purposes.

BE IT FURTHER RESOLVED, that the southerly half of

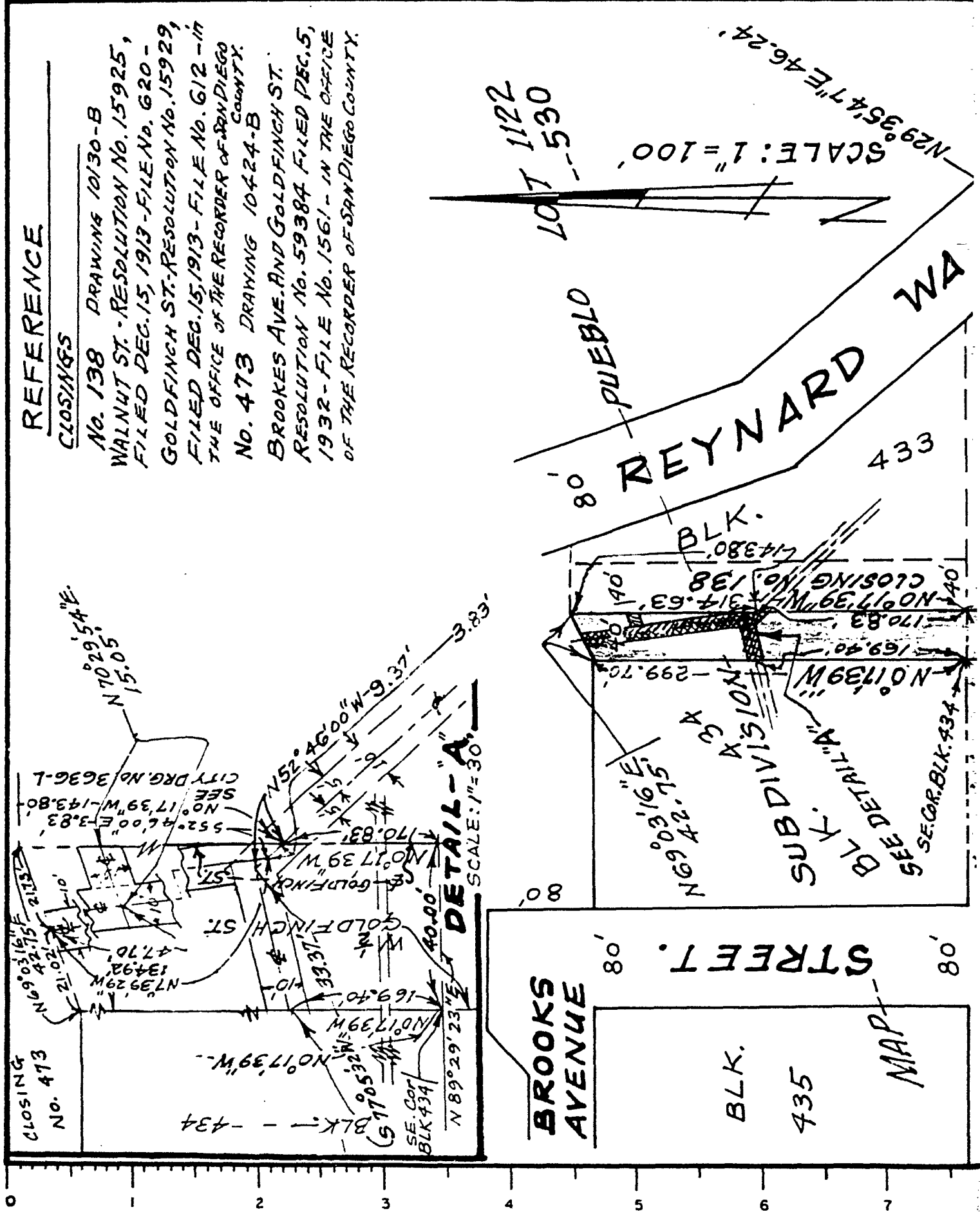
