

RESOLUTION No. 220796 (R-78-1936)

Adopted on MAY 2 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Seventh Amendment to the Joint Powers Agreement (creating the San Diego Regional Employment and Training Consortium) with the COUNTY OF SAN DIEGO for the purpose of promoting the timely processing of RETC grant agreements (and modifications) with the Department of Labor by no longer requiring the signature of the City Manager and Chief Administrative Officer but only requiring the signature of the RETC Executive Director, following authorization by the RETC Policy Board, pursuant to the terms and conditions set forth in the Seventh Amendment to Joint Powers Agreement on file in the office of the City Clerk as Document No. 763419.
