BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$49,988 by Ernie Reason, Jr., for refurbishment of Horton Plaza Fountain in the City of San Diego, is hereby accepted; and the City Manager is hereby authorized to execute for and on behalf of the City a contract therefor on file in the Office of the City Clerk as Document No. 762781.

2. That Horton Plaza Park Improvement Fund 2822 (Object No. 3275) be and it is hereby established.

3. That the City Auditor and Comptroller be and he is hereby authorized to transfer \$70,000 from Redevelopment Agency Horton Plaza Fund 984 to Horton Plaza Park Improvement Fund 2822 of The City of San Diego, and that expenditure of said funds is hereby authorized solely and exclusively for the purpose of providing funds for the refurbishment of Horton Plaza Fountain and other related project costs.
