BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. Seagrave Fire Apparatus Inc. and 2. International Harvester Co. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of Fire Apparatus and Equipment as follows:

1. Seagrave Fire Apparatus Inc. for Section 1 - the purchase of two (2) 1500 GPM Triple Combination Pumpers (without additional equipment) for a cost of \$85,233.00 each; terms net 30 days plus sales tax with an option to purchase up to eight (8) additional 1500 GPM Pumpers (without additional equipment) within twelve (12) months of the bid opening date for a price not to exceed 5% over bid price.

2. International Harvester Co. for Section 11 - Two (2) brush rigs (without additional equipment) for a cost of \$51,771.63 each; terms net 30 days plus sales tax with an option to purchase up to four (4) additional Brush Apparatus within twelve (12) months of bid opening date for a price not to exceed 10% over bid price.  
Section 111 - Two (2) Brush Rigs for a cost of \$74,135.60 each; terms net 30 days plus sales tax with an option to purchase up to two (2) additional Brush Rigs within twelve (12) months of bid opening date for a price not to exceed 10% over bid prices.
