BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled
"EASTVIEW UNIT NO. 2 Being a subdivision of a portion of
Parcel 1 of Parcel Map No. 6677, in the City of San Diego, County
of San Diego, State of California, according to Map thereof on
file in the office of the Recorder of said County." is made in
the manner and form prescribed by law and conforms to the
surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, the following: Devereux
Road and Marymont Place for public purposes; and said streets
are hereby declared to be public streets and dedicated to the
public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on
behalf of The City of San Diego, a municipal corporation, the
easement for open space over, under, upon, and across those
portions of Lots 1, 2, and 3, as granted and shown on said map
and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map and that said
public streets are accepted on behalf of the public as heretofore


