

RESOLUTION No. 220818 (R-78-1973)


Adopted on MAY 8 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of KEN TAYLOR, DBA STERLING BUILDERS, executed in favor of The City of San Diego, bearing date of March 6, 1978, conveying to said City a permanent easement and right of way for public street and incidents thereto over, under, upon, along and across the southerly 10 feet of Lots 73, 74, and 76, Highdale Addition to Encanto Heights, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named RADIO DRIVE.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
