BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$14,500 from Capital Outlay Reserve Fund 245 of The City of San Diego is hereby authorized solely and exclusively for the purpose of providing funds for converting the traffic signal and street lighting services and installing new luminaires and electroliers as needed on India Street from Kalmia to Maple Streets, on Kettner Boulevard from Laurel to Olive Streets and on Laurel Street from California to Columbia Streets.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the above referenced project pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.
