BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$142,985.00 by G. R. HENDERSON CONSTR. INC., a corporation, for the CONSTRUCTION OF KEARNY MESA PRESSURE REGULATING STATIONS, in the City of San Diego, California, is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 762014.
2. That the expenditures \$84,000.00 out of Water Revenue Fund 502, and \$108,000.00 out of Water Revenue Fund 502 Unallocated Reserve, of the City of San Diego are hereby authorized solely and exclusively for providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$108,000.00 within Water Revenue Fund 502 from the Unallocated Reserve (69.79) to Construction Outlay (66.92).
