

RESOLUTION NO. 220859 (R.78-2134)

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to ALTA VIEW DRIVE, ALSACIA STREET, QUEBEC COURT, RITVA PLACE, WOODMAN STREET, PARIS WAY and RAMFOS PLACE, affecting BAY TERRACES UNIT NO. 4, Map 6722 filed in the office of the County Recorder; and

WHEREAS, The Donald L. Bren Company, a California corporation, owner of the land, has requested that the City revest these abutter's rights of access in the property to allow better utilization of the land; and

WHEREAS, those abutter's rights of access that are necessary for the development that is proposed will be relinquished by the map of Bay Terraces Unit No. 4 Subdivision; and

WHEREAS, the City Manager recommends that said access rights be revested in the property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. 763549, to The Donald L. Bren Company, a California corporation, affecting the revestment of those aforementioned abutter's rights of access
