APPROVING MAP OF BAY TERRACES UNIT NO. 4 RESUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by RONALD D. HOGAN, a Registered Civil Engineer, entitled "BAY TERRACES UNIT NO. 4 - RESUBDIVISION Being a subdivision of Parcels 1 through 4 of Parcel Map No. 7007, in the City of San Diego, County of San Diego, State of California, filed in the office of the County Recorder of San Diego County, March 16, 1978, together with Ritva Place and Quebec Court and portions of Alta View Drive, Alsacia Street, Woodman Street, as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Alsacia Street, adjacent and contiguous to Lots 5 through 8; in and to Alta View Drive, adjacent and contiguous to Lots 3 through 5; in and to Paris Way, adjacent and contiguous to Lots 1 through 3; in and to Ramfos Place, adjacent and contiguous to Lots 1 and 9; and in and to Woodman Street, adjacent and contiguous to Lots 8 and 9, all as shown on this map within this subdivision and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the general utility easement over, under, upon, and across Lots 1 through 9, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as well as the general utility easement, all as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
