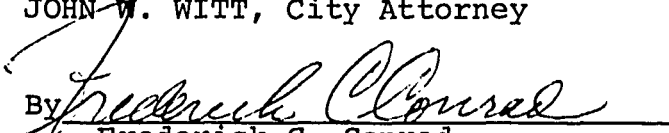
Adopted on MAY 15 1978
