

RESOLUTION No. 220865 (R-78-2064)


Adopted on MAY 15 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Director's Deed of the STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION, executed in favor of The City of San Diego, bearing date of February 28, 1978, granting to said City the Southerly 14.00 feet of the West 120.00 feet of the East 445.00 feet of the East half of Lots 14 and 15 in Cave and McHatton Subdivision of Lot 14 and part of Lot 16, Ex-Mission Partition, according to Map thereof No. 159 filed in the County Recorder office, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SKYLINE DRIVE.

That the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Property Director for further handling.
