BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant and Slope Easement Deed of GLORIA M. SCHIFF, a married woman, conveying an interest as her sole and separate property, executed in favor of The City of San Diego, bearing date of January 18, 1978, conveying to said City all that portion of Lots A-83 and A-84 of San Ysidro, according to Map thereof No. 1174 filed in the Office of the County Recorder, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named BEYER BOULEVARD.
