

RESOLUTION No. 220871 (R-78-1989)


Adopted on MAY 15 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of FRANK MOORE and ELVIRA MOORE, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of February 27, 1978, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across the Northwesterly 14.00 feet of Lot 2, Block 8, Sunnyslope Addition to Encanto Heights, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named MADERA STREET.

That the City Clerk shall cause a certified copy of this resolution attested by him under seal, to be recorded in the office of the County Recorder.
