WHEREAS, at the City Council meeting on May 2, 1978, the matter of vacating the southerly half of Walnut Street, from Otsego Drive to Falcon Street, and the westerly half of Goldfinch Street, from Walnut Street to Brookes Avenue, was heard and then the hearing was closed and the Council adopted a resolution vacating said street portions; and

WHEREAS, Councilman Haro, who was unable to attend the portion of the meeting which included said action, had been contacted by concerned residents in the area adjacent to the proposed street vacation and he had indicated to said persons who were protesting said vacation that he, Councilman Haro, would request a continuance of the matter so that the interested persons could have additional time to prepare their arguments in opposition to the vacation; and

WHEREAS, the protestants, apparently in reliance upon Councilman Haro's statement, did not appear at the May 2, 1978 meeting to protest the vacation; and

WHEREAS, Councilman Haro indicated shortly after the meeting of May 2, 1978 that he would move to reconsider the street vacation at the next Council meeting and, based upon that representation, the City staff and the applicant for the street vacation were notified of such intention; and

WHEREAS, the public welfare and safety require a reconsideration of the vacation in view of the reliance

by the protestants to the vacation upon a representation by a councilmember that a continuance would be requested and therefore the councilmembers present at the May 2, 1978 meeting did not hear the arguments against the vacation of the street; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That Resolution No. 220537, vacating portions of Walnut Street and Goldfinch Street, is hereby rescinded and the Council hereby declares its intention to reconsider the matter of vacating the southerly half of Walnut Street, from Otsego Drive to Falcon Street, and the westerly half of Goldfinch Street, from Walnut Street to Brookes Avenue.

BE IT FURTHER RESOLVED, that the City staff is hereby authorized and directed to renotice the hearing on the proposed street vacation.
