

RESOLUTION NO. 220889

MAY 22 1978

WHEREAS, in the November 1977 General Municipal Election the citizens of San Diego expressed their desire for paramedic services in the City of San Diego; and

WHEREAS, the City Manager, with the concurrence of the Public Services and Safety Committee, appointed a Paramedic Proposal Evaluation Committee who issued a report dated April 20, 1978 recommending that The City of San Diego enter into a contract with Medevac, Inc. for the provision of paramedic services to the City of San Diego; and

WHEREAS, the Public Services and Safety Committee on April 26, 1978 held a public hearing in the matter of the recommendations of the Paramedic Proposal Evaluation Committee; and

WHEREAS, during said public hearing, Mr. Joe Dolphin, President of Medevac, Inc., represented to the Committee that if awarded the contract to provide paramedic services in the City of San Diego, Medevac, Inc. would agree to a provision in the contract to move its corporate headquarters to San Diego and would agree to a provision in the contract that at least forty percent (40%) of the personnel employed by Medevac, Inc. in San Diego will be minorities and women; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that City staff are directed to initiate contract negotiations

with Medevac, Inc. for the provision of paramedic services for the City of San Diego.

BE IT FURTHER RESOLVED, that said contract should include provisions which will insure the relocation of Medevac's corporate headquarters to San Diego, require that at least forty percent (40%) of the personnel employed by Medevac, Inc. in San Diego be composed of minorities and women, include performance measures and a requirement for quarterly reports on performance and compliance with the City's Affirmative Action Program.
