BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, agreements with 33 youth-serving community agencies in order to implement the 1978 Recreation Support Program (RSP), copies of which are on file in the office of the City Clerk and designated below.

BE IT FURTHER RESOLVED, that the expenditure of \$7,000 from Special Fund 2653 by the Park and Recreation Department (Recreation Division) for the purpose of conducting Recreation Support Program activities is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure of \$175,000 from Special Fund 2653 is authorized, contingent upon the adoption of the Fiscal Year 1978 appropriation ordinance.

BE IT FURTHER RESOLVED, that the following agencies and agreements be approved to carry out the 1979 Recreation Support Program in compliance with all appropriate laws, rules and regulations:
