

**RESOLUTION No. 220914** (R-78-2125)

Adopted on **MAY 23 1978**

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the Purchasing Agent be, and he is hereby authorized and empowered to advertise for bids for the reconstruction of the following storm damage facilities in The City of San Diego:

1. Construction of a retaining wall to retain a cut slope adjacent to Talbot Street which supports a private residence on Martinez Street.
2. Construction of a retaining wall to reestablish a portion of the outboard driving lane and shoulder combined with a drainage facility on North Torrey Pines Road one-half mile north of the reservoir.
3. Reconstruction of the sidewalk and protection fence in the 1200 block of Coast Boulevard.
4. Reconstruction of a destroyed drainage facility, surrounding fill slope and roadway in the 7000 block of Country Club Drive.
5. Construction of a retaining wall to support an unstable cutslope and reconstruction of a displaced drainage system in the 2600-2700 block of Torrey Pines Road.
6. Reconstruction of the breached portions of the Murphy Canyon and San Diego River Dikes including the maintenance cleaning of the Murphy Canyon Channel adjacent to and east of San Diego Stadium.
7. Reconstruction of flood damaged portion of Fashion Valley Road north of Hotel Circle and south of Friars Road.
8. Construction of subsurface and surface drainage facilities on Hillside Drive.
9. Reconstruction of breached dike separating San Diego River flood channel and Camino de la Reina with permanent improvements to the flood channel along Camino de la Reina at Route 163.
10. Reconstruction of Tijuana Road at Tijuana River.
11. Installation of retaining wall north of Lea and south of University Avenue on west side of 54th Street.
12. Reconstruction of a destroyed drainage facility, sidewalk and supporting fill slope on west side of College Avenue north of El Cajon Boulevard.

13. Reconstruction of a destroyed drainage facility and supporting slope in the 6300 block of Oakridge.

14. Reconstruction of a collapsed drainage facility and bank at the intersection of Washington and Bush Street.

15. Reconstruction of a destroyed drainage facility and supporting slope on westside of Gilman Drive between Villa La Jolla and La Jolla Village Drive.

16. Restoration of storm damaged Shaw Valley Bridge south of Carmel Valley Road.

17. Restoration of El Camino Real Bridge at San Dieguito River.
