

RESOLUTION NO. 220319

APPROVING MAP OF SCRIPPS RANCH BUSINESS PARK UNIT TWO

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, a Registered Civil Engineer, entitled "SCRIPPS RANCH BUSINESS PARK UNIT TWO Being a subdivision of Lot 1, Sherman-Fairchild Park Unit No. 1, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7170, filed in the office of the County Recorder of San Diego County, January 12, 1972, together with a portion of Willow Creek Road as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Business Park Avenue and Old Grove Road, together with pedestrian and non-motor vehicular use, for public purposes; and said streets and right of way are hereby declared to be public streets and public right of way and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.



The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map, and that said public streets and public right of way for pedestrian and non-motor vehicular use are accepted on behalf of the public as heretofore stated; and that those certain easements for drainage facilities as well as the open space easement as granted and shown on this map within this subdivision are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
