BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer \$1,025 from General Fund 100 (Unallocated Reserve 53.20) to Purchasing Department 0800 (Non-Personal Expense) solely and exclusively for the purpose of providing funds for the above referenced travel.
