WHEREAS, his report indicates, among other things, that the applicant, MR. SEBASTIAN MENDOLA, dba Service Cab Company which is wholly owned by Mr. Mendola whose character and fitness recommend him to engage in the business of operating taxicabs; and


WHEREAS, the Council this date has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,
