WHEREAS, an application for transfer of an individual owner/operator certificate of public convenience and necessity from ANDRES W. OLIVERIO, dba Andresida Cab Company, to HERBERT JOSE OLIVERIO to operate a taxicab within the limits of the City of San Diego has been received; and

WHEREAS, pursuant to Section 72.0101(h) of the San Diego Municipal Code, the City Manager has caused an investigation to be made and has reported his findings in writing to this Council; and

WHEREAS, his report indicates, among other things, that the applicant, MR. HERBERT JOSE OLIVERIO, dba Andresida Cab Company which is wholly owned by Mr. Oliverio whose character and fitness recommend him to engage in the business of operating taxicabs; and

WHEREAS, the Council this date has found the contents of the City Manager's report to be correct and accurate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the transfer of an individual owner/operator certificate of public convenience and necessity for a taxicab, as more particularly set forth above, be and it is hereby approved, subject to the following conditions precedent:

(1) That the transferee comply with all provisions of the San Diego Municipal Code.


