WHEREAS, it is the recommendation of the Centre City Development Corporation after due consideration that the use of older, architecturally significant buildings within the Centre City redevelopment areas be encouraged with the objective of consolidating city office functions in a single older office building; and

WHEREAS, it is an important goal of the Centre City Plan to conserve and upgrade buildings of significant architectural value; and

WHEREAS, office space exists in older, architecturally significant buildings at a cost which is competitive with that of new structures; and

WHEREAS, federally funded programs may be available to assist the City in creation of office space in older, architecturally significant buildings; and

WHEREAS, it has been the experience of Seattle and other major west coast cities that upgrading and use of older office buildings has had a beneficial impact on redevelopment plans; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the use of older architecturally significant buildings in Centre City redevelopment areas for office space is hereby encouraged.


