
Adopted on MAY 30 1973

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Grant Deed of GUILLERMO C. BARRIOS and ANTONIA C. BARRIOS, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of February 28, 1978, conveying to said City all that portion of the East one-half of Lot 59, Subdivision No. 5 of Lot 12 of Ex-Mission Rancho, in the City of San Diego, County of San Diego, State of California, according to Licensed Survey Map No. 63, filed in the Office of the San Diego County Recorder September 6, 1894, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named 71st Street.

That the City Clerk of said City be, and he is hereby authorized and directed to deliver said deed to the Property Department for further handling.
