
Adopted on MAY 30 1978

BROWN, husband and wife as joint tenants, executed in favor of The City of San Diego, bearing date of March 4, 1978, conveying to said City all that portion of Lot 59, Subdivision No. 5 of Lot 12 of Rancho Mission of San Diego, in the City of San Diego, County of San Diego, State of California, according to Licensed Survey Map No. 63, filed in the Office of the San Diego County Recorder September 6, 1894, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street, and the same is hereby named 71st Street.
