

RESOLUTION No. 220976 (R-78-2213)


Adopted on MAY 30 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of JEFFREY M. YADDOW and LINDA JEAN YADDOW, One-Half Undivided Interest; and ELSE A. FULLER, as to the Remainder, executed in favor of The City of San Diego, conveying to said City the South 25.00 feet of the South 145 feet of the West 150 feet of Lot 3 of the Sullivan Tract according to Map thereof No. 1724, filed in the Office of the San Diego County Recorder on December 19, 1921, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named SOLITA AVENUE.

That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.
