

RESOLUTION No. 220979 (R-78-2220)

Adopted on MAY 30 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. Pursuant to authority conferred by and in accordance with the provisions of Sections 32 and 35701 of the California Vehicle Code, the use of the following described street be and it is hereby prohibited at all times to commercial vehicles of a gross vehicular weight rating of one-ton (2,000 pounds) or more:

CHAMOUNE AVENUE, between University Avenue and Redwood Street;

providing that this use limitation shall not apply to passenger buses or public utility vehicles under the jurisdiction of the Public Utilities Commission or commercial vehicles having a destination or point of origin on such street.

2. That the installation of the necessary signs and markings be and it is hereby authorized to be made on said street.

3. That the regulation hereinabove imposed shall become effective upon the installation of such signs.
