

RESOLUTION NO. 220992

WHEREAS, local coastal program regulations pursuant to the 1976 California Coastal Act require the submittal by local governments to the coastal commissions of issues identification prior to submittal of the local coastal program; and

WHEREAS, the Planning Department has prepared a draft issue identification report for the Coastal Zone portions of the Mira Mesa Community Plan and the Western Mira Mesa Community Plan; and

WHEREAS, it is appropriate to insure that the above mentioned issues identification report adequately addresses the applicable policies of the Coastal Act; and

WHEREAS, there has been adequate informal staff review of the above mentioned document between the staffs of the Planning Department and the San Diego Coast Regional Commission; and

WHEREAS, the Planning Department has submitted the above mentioned document to the City Council Rules Committee for consideration, and the Rules Committee has reviewed this material and found it appropriate with respect to implementing the Coastal Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Council formally approve the submission to the coastal commissions of the Mira Mesa Issue Identification report, on file in the office of the City Clerk as Document No. 763758.
