

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by JOHN B. FOX, a Registered Civil Engineer, entitled "LA JOLLA BLUFFS Being a subdivision of a portion of Lot 1 according to Referee's Partition Map of Pueblo Lots 1312 and 1313, in the City of San Diego, County of San Diego, State of California, being Map thereof No. 968, filed in the office of County Recorder of San Diego County, December 13, 1905.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the unnamed street, La Jolla Shores Lane and the easement for pedestrian and non-motor vehicular use, for public purposes, and said streets and easement are hereby declared to be public streets and a public easement and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation,

the easement for open space over, under, upon, and across Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and easement for pedestrian and non-motor vehicular use, together with the easement with the right of ingress and egress for the construction and maintenance of water facilities, and the open space easement as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
