

RESOLUTION No. 221023 (R-78-2214)

Adopted on JUN 5 1978

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that street easement deed of AVCO COMMUNITY DEVELOPERS, INC., a California corporation, executed in favor of The City of San Diego, conveying to said City a permanent easement and right-of-way for a public street, and incidents thereto, over, under, upon, along and across all that real property known as Parcel 1, Bernardo Center Drive, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named BERNARDO CENTER DRIVE.

That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the San Diego County Recorder.
