


RESOLUTION NO. 221033 JUN 5 1978

WHEREAS, recognizing the disaster that befell one of San Diego's most historical landmarks, the Aerospace Museum, Point Homa High School has initiated a benefit dance to raise funds to be donated to the rebuilding of this facility for the education and enjoyment of fellow citizens of San Diego and other visitors; NOW, THEREFORE,

BE IT RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer not to exceed \$500 from the Transient Occupancy Tax Fund (224) Contingency Reserve (52.99) to the Convention and performing Arts Center Fund (254) to reimburse said fund for costs incurred in providing free use of the Copper Room for a dance sponsored by Point Loma High School to benefit the Aerospace Museum.

BE IT FURTHER RESOLVED, that Point Loma High School is hereby commended for its action.
