BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the REGIONAL EMPLOYMENT AND TRAINING CONSORTIUM (RETC) to allow the San Diego Regional Youth Employment Program (REGY) to implement the 1978 Summer Program for Economically Disadvantaged Youth (SPEDY), under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 763625.

BE IT FURTHER RESOLVED, that the San Diego Regional Youth Employment Program (REGY) contract with fourteen (14) selected Local Education Agencies listed in Attachment "A" and with the Oceanside Chamber of Commerce to carry out portions of the program under Title III of the Comprehensive Employment and Training Act (CETA).
