

RESOLUTION NO. 221047

JUN 5 1978

WHEREAS, State Route 15 is included in the City of San Diego's General Plan (April 1972) and State Route 15 is shown on the Regional Transportation Plan (April 1977) and State Route 15 is included in the Federal Aid Primary system; and

WHEREAS, the Regional Transportation Improvement Plan for Fiscal Years 1979-1983 includes funds for preliminary engineering and acquisition of right-of-way only and funding for construction is proposed after 1983; and

WHEREAS, the Health and Safety of the citizens using State Route 15 is increasingly endangered since the 1977 intersection-related accidents have increased 25% over the 1976 total, and construction of State Route 15 to freeway status would eliminate nine at-grade intersections and thus eliminate the accidents related thereto; and

WHEREAS, the sub-standard street sections are inadequate for the average daily traffic volumes of over 20,000 vehicles, thus causing undue delay resulting in average vehicle speeds so low that air quality and fuel economy is adversely affected; and

WHEREAS, intra-community circulation is severely impaired by through traffic on State Route 15, and this is contrary to the City of San Diego's policy to revitalize the older sections of the city; NOW, THEREFORE,

BE IT RESOLVED, that this Council shall exert a maximum effort at the State and Federal levels to expedite the addition of State Route 15, between Interstate 5 and Interstate 8, into the Federal Aid Interstate System and to expedite the construction schedule for this freeway.
