

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE SANTA ANITA AND SAN DIMAS STREETS AND THE ALLEY, MAP 3900, AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

JUN 5 1978

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of streets and alley hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of SANTA ANITA and SAN DIMAS STREETS and the ALLEY, MAP 3900, as more particularly shown on Drawing No. 17644-D on file in the office of the City Clerk as Document No. 763665.

The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 4:00 P.M. JUN 27 1978 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.


