

RESOLUTION No. 221057

(R. 78-2094)

Adopted on JUN 6 1978 <sup>REVISED</sup>

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City's contribution of \$1,631,499.94 is hereby authorized for the improvement of BEYER BOULEVARD FROM DAIRY MART ROAD TO I-805, as more particularly described in Resolution of Intention No. 220614 and pursuant to the Municipal Improvement Act of 1913.

BE IT FURTHER RESOLVED, that the expenditures of \$197,314 from Gas Tax Funds and \$948,250 from Capital Outlay Fund 245 be hereby authorized, solely and exclusively, for the above stated purpose.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sums of \$53,414 from the Gasoline Tax Unallocated Reserve (CIP 90-220) and \$70,000 from the Capital Outlay Fund Unallocated Reserve - Flood Control (CIP 90-245.2) to CIP 52-110.1, Beyer Boulevard.
