WHEREAS, in proceedings under the Municipal Improvement Act of 1913 (commencing with Section 10000, Streets and Highways Code) the Council adopted Resolution No. 220291 ordering the giving of notice inviting sealed bids for the construction of the improvements referred to in the resolution and the notice has been duly published; and
