WHEREAS, it is proposed that the Redevelopment Agency of The City of San Diego acquire the City interest in certain property acquired by the City of San Diego from The Salvation Army, Inc., generally described as Lots C, D, E and F in Block 67 of Horton's Addition; and


WHEREAS, it is proposed that the City sell its interest in Lots C, D, E and F of Block 67 of Horton's Addition of San Diego to The Redevelopment Agency of The City of San Diego to be used for redevelopment purposes; and

WHEREAS, it is proposed that The Redevelopment Agency pay the City of San Diego the sum of \$710,000 for said property; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of said City, a grant deed, a copy of which is on file in the office of the City Clerk as Document No. 763781 granting to The Redevelopment Agency of The City of San Diego, a public body, corporate and politic, Lots C, D, E and F of Block 67 of Horton's Addition, as more particularly described in said deed.
