

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to California Public Resources Code, Section 21081, the following findings are made with respect to the environmental impacts identified in the First Amendment to Environmental Impact Report No. 77-06-02:

1. Noise

a. Impact: Traffic adjacent to Unit 8, Lot 88, which fronts Bernardo Center Drive, and Unit 5, Lots 70-78, which are adjacent to I-15, would impact the development with noise in excess of 65 CNEL.

b. Mitigation: Construction by the subdivider will provide noise buffers approved by the City to mitigate the noise either as earthen berms or solid walls, or a combination of both.


2. Archaeology

a. Impact: Development of Units 5-9 would eliminate two archaeological sites.

b. Mitigation: The developer, as a condition of final map approval, shall cause to be conducted surveys of the identified sites using the recommended methods as outlined in EQD 77-06-02 which also covers these sites.
