RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, AWARDING IMPROVEMENT BONDS

(Tia Juana River Flood Improvement District)

Section 1. The bid for the bonds yielding the lowest

offering to purchase the bonds for 91.35 % of their par
value and a premium of 0.00 , the bonds to bear
interest at the rate of 8 % per annum. The bid is
hereby accepted and the bonds awarded to said bidder in
accordance with the terms of such bid.

Section 2. All bids other than the bid above accepted are hereby rejected and the Purchasing Agent is directed to return the checks accompanying the rejected bids to the respective bidders.

Section 3. The interest rate on the bonds is hereby fixed at the rate stated in Section 1.

Section 4. The Treasurer is directed to deliver to the successful bidder bonds, in the amounts and at the time and manner provided by law, upon payment by the successful bidder of 91.35% of the par value of the bonds delivered, a premium of 90.00, and accrued interest from the date of the bonds to the date of delivery.
